# Short Camp Permits

FROM THE FIELD COMMISSIONER FOR BEDFORD-SHIRE, BUCKINGHAMSHIRE, HERTFORDSHIRE AND OXFORDSHIRE - TO CO-ORDINATOR

Just to let you know that I do read with great care and interest this very fine District Newsletter.

This is no local fault and will no doubt be picked up by the D.C. but, there is a change in policy regarding Short Camp Permits.

Camping is a basic and normal activity for Scouts and everything should be done to make the administration arrangements as simple as possible. The Committee of the Council on the recommendation of the National Scout Board has therefore decided that the Permit Card will be discontinued with immediate effect. The new arrangements which will be published in the new P.O.R., may be summarised as follows:

STANDING CAMPS OF FIVE NIGHTS OR MORE. Form P.C. to be used as at present.

## <u>CAMPS OF "FOUR NIGHTS, OR LESS HIKES AND EXPEDITIONS</u>

Scouts and Venture Scouts must be either in uniform or in possession of their Progress Book so that when necessary they can be identified as members of the Movement. The Group Scout Leader should know that the camp, hike or exped-

ition is taking place so that in case of any emergency there is somebody in the home area who knows of the whereabouts of the members of the Group.

I think it is vital to emphasise the importance of the G.S.L. or Scouter in Charge of the Group to know that the activity is taking place and is provided with a list of those attending, also a programme of movement and approximate timing.

# SCOUTERS' WARRANTS AND TRAINING

WE REPRODÜCE FROM THIS MONTH'S "HERTFORD-SHIRE SCOUT NEWS" A NOTICE FOR THE SPECIAL ATTENTION OF GSLs and Scouters in charge of Groups.

The census revealed a large number of Scouters described as "acting" or "on probation", in respect of whom no forms LP1 (Application for Leader Permit) have been completed.

Please obtain forms from your DSC \* Secretary and ensure cômpletion as soon as possible.

When Scouters cease to operate with your Group, please advise your DSC Secretary <u>immediately</u>, giving date and reason (together with Warrant or Leader Permit if obtain):Le) for cancellation.

## The New Warrant Procedures

THESE CAME INTO FORCE ON 1 APRIL 1968, AND THE FOLLOWINC NOTES ARE EXTRACTED FROM AN ARTICLE IN THE APRIL EDITION OF "THE SCOUTER":

#### Leader Permit

Following an approach by or to an applicant, and following a clearance from Headquarters, the District Commissioner will interview the applicant and his nominator (Sponsoring Authority or GSL), and if satisfied the necessary application fora will be completed and passed by the DC to the District Secretary. One part of thas form is sent to Headquarters, the other part being retained by the District Secretary.

On receipt of the HQ portion of the form, a Leader Permit will be prepared. and sent to the District Secretary, who will arrange for the applicant to provide referees and to meet the District Warrants Committee .

If the li rents Committee' approves the appointment the District Secretary endorses the appointment into the Leader Permit at the meeting and sends the Permit to the DC for presentation to the new Scouter on a suitable occasion mutually agreed upon.

The Scouter then does his Initial Training and will then, under arrangements which will normally be made by the ADC (Leader Training), undertake the necessary Basic Training, which he will have two years to oamplete.

When he has completed the Basic Training the Scouter hands in his Leader Permit to the District Secretary and, if it is his wish, requests the issue of a Leader Warrant. If he does not complete the Basic Training within two years or if he does not wish to receive a Leader Warrant, the Lender Permit is withdrawn.

#### Leader Warrant

If the DC and the Warrants Committee are satisfied that the Leader Permit holder, having completed his Basic Training, is suitable to be granted a Leader Warrant, then the necessary form is completed and sent to Headquarters, who will issue a Leader Warrant Record Book for presentation by the District Commissioner.

After receiving a Leader Warrant, a GSL or Section Leader is required to complete the Advanced Adult Training within five years. If the appropriate training has not been completed the appointment will lapse.

Assistant Section Leaders have no obligation to complete the Advanced Training but will be encouraged to do so.

Existing Warrant Holders: Training Obligation

Holders of existing Warrants as Commissioners, or as District Scouters, GSLs, VSLs or Leaders of Training Sections, who have not yet done so are expected to complote the Advanced Leader Training within five years from 1 April 1968.

# We need more Scouters

.--and we need them urgently. You who are Scouters are obviously keen and - sincere people deeply interested in our youth (or you wouldn't be volunteer leaders as you are). Now is the time to show your sincerity in yet another way by finding one lay member apiece who would like to become a Scouter but hasn't made the first move himself because he "doesn't know how to do the Job".

Talk to him and tell him how he will be helped in every possible way. Show him the summary of Warrant procedure on this page - which is not nearly as painful as it might sound! - and let him see what the training courses are.

BASIC TRAINING is in two parts: A and B. Part A is the basic information course, taking two evenings, usually at the local headquarters. (THERE IS A PART "A" COURSE IN LETCHWORTH ON 10 AND 11 JULY: SEE PAGE 4)

Part B is the Basic Practical Course, which is usually one Saturday and Sunday locally or in a nearby District. (THERE IS A LIST OF THESE "B" COURSES ON THE BACK PAGE OF THIS MONTH'S "HERTFORDSHIRE SCOUT NEWS")

ADVANCED PRACTICAL COURSES follow Basic Training. These may be at Gilwell Park for a week, or at our own County training centre at Well End over three

or four weekends. (FULL LISTS OF THESE APPEAR UNDER THE HEADING "WOOD BADGE COURSES" EACH MONTH IN "THE SCOUTER", AND COURSES AT WELL END ARE ALSO ADVLR-TISED WITH APPLICATION FORMS IN "HERTFORD-SHIRE SCOUT NEWS")

A CORRESPONDENCE COURSE is also provided as part of the Leader Training scheme. This may follow the Advanced Practical Course, though it can be begun at any time. It is not an "exam".

FINALLY, up to six months practical Scout leadership with your Troop or Pack leads to the honour of presentation of the Wood Badge - the emblem of a trained and qualified Leader in the Scout Movement.
